DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached frame house being three bays wide and two bays in depth with a one story brick two bay square "L" shaped wing with a one story frame summer kitchen extension and that being three bays long and one bay wide. The house is covered by wood siding and may be of log construction as it has very old interior features such as four and six panel doors and an unusually low entrance to the second floor enclosed stairway. The front entrance occupies the center bay with a glass over panels door approached by a wooden stoop. All windows are of 6/6 sash with smaller sizes on the rear and with wood lintels and sills. The attic is lighted by two 2/2 sash in each gable. The front section has a moderate slope "A" frame roof and the wings have shed roofs, all being of metal. Double flue chimneys rise on either side of the front section. There are simple boxed cornices on the front and rear. This house rests on a rather high fieldstone foundation.
