## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the right side and it is three bays wide, four bays in depth, and with an "L" shaped, two story brick wing being two bays wide and three bays long with a side balcony. There is also a one bay long cement block extension. On the right side of the front section is a deep first floor porch covered by a second story uncovered gallery supported by brick piers. All brickwork is in common bond, painted. The front entranceway occupies the left bay with a glass over panels door and a rectangular transom. This is approached by an attractive brick porch with iron railings. First floor front windows are of 1/1 sash and those on the second story have 2/2 sash, all with three row header brick arches as over the door. Rear area windows are a combination of 6/6 and 2/2 with either wood lintels or segmental brick header arches. The doors have glass over panels. The attic is lighted by a 6/6 sash window in the right gable. The moderate slope "A" frame roof of the front section has had its original wood shake shingles replaced by asbestos shingles. The wing has a metal shed roof. The front roofline has a decorative three string brick cornice with the center row being in a dentil pattern. The rear roofline has a two string brick cornice. The building rests on a rather high fieldstone foundation.
