DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house and former shop detached on the left side. It is four bays wide and two bays deep with a full width, one bay deep wing and an added wing three bays wide and two bays deep, one story frame construction. The entranceways occupy the inner bays with glass over panel doors and narrow overlights. All front windows are of 1/1 sash and a wide shop window is in the left bay. Rear area windows are of 2/2 sash and there are four panel doors. The front section has a low slope "A" frame roof with a long shed or "colonial catslide" roof extending over the first full width wing. The second wing has another long sloping roof taking off from the ridge over the first wing roof, and all are of metal. There is a double chimney at each end of the front section and it rests on a three string brick cornice on the front. This building appears to be of frame construction but the brick cornice and a small hole in the aluminum siding reveals the brickwork. It rests on a street level foundation.
