**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a narrow 2-1/2 story brick house detached on the left side and is two bays wide and approximately three bays in depth with a full width, one story frame wing covered by clapboards and two bays square. All brickwork is common bond. The entranceway occupies the right bay with a four panel door and segmental arched transom. All windows are of 2/2 sash with segmental brick arches, as over the doorway, but rear windows have wood lintels and sills. Louvered shutters protect the front windows. The attic is lighted by two small 4/4 sash windows on the exposed left side. The front section has a moderate slope "A" frame roof resting on three string brick cornices, front and rear, and a wide enclosed chimney rises from the left gable. The wing has a shed roof and both are of metal. This house sets on a moderately high fieldstone foundation.
