**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached house being three bays wide and two bays in depth with a brick, two bay square wing with a side balcony and a two bay square frame extension. All brickwork is of common bond. The front entranceway occupies the left bay with a glass over panels door and segmental arched transom. This is approached by a <sup>Seven</sup> ~~seven~~ step porch with wrought iron railing. The center bay contains a double 1/1 sash window with a grooved mullion and moulded capital as used elsewhere in this block. The infill of the segmental arch is filled with incised scrolls. The base of this window has a shelf lugsill. To the right of this is a wide enclosed "carriage entrance" fronted by a board and batten gate with a heavy wood lintel supporting the second story. Second floor front windows are also of 1/1 sash and are topped by two row header brick arches as on the first floor. There also have louvered shutters. Rear area windows have 6/6 sash with wood lintels and sills. Rear doors are of glass over panels. The front section has a rather moderate slope, metal "A" frame roof with a small chimney rising from the center of the gable. The wing has a metal shed roof. Front section rooflines are supported by two row brick cornices on the front and rear. The house rests on a high fieldstone foundation.
