DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the left side. It is two bays square with a full width, two story brick wing being four bays long and built at the same time. All brickwork is in common bond. There is a rear balcony. The front entrance occupies the left bay with a glass over panels door and a segmental arched overlight. On the right is a wide 1/1 sash window and second story front windows are 1/1 sash, also, and all have two row brick header segmental arches with roundels in the infils, as over the door. The front window of the basement is of 2/2 sash with the same design as above. Rear area windows are also 1/1 sash and with wood lintels and sills with louvered shutters. Doors have glass over panels. The front section has a moderate slope "A" frame roof and the wing has a shed roof, both of metal. The front section roof rests on two string brick cornices, and there is a small enclosed chimney on the right. The house is on the side of an inclined street and has a very high fieldstone foundation necessitating a porch of seven steps to the door.
