DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#217 is a 2-1/2 story detached brick house three bays wide and two bays in depth with a one story brick "L" shaped wing 1-1/2 bays wide and two bays in depth with a frame second story, two story frame extension of three bays and a long side balcony. All brickwork is of common bond. The front entrance occupies the right (N) bay with a four panel door, white marble sill, paneled enframement and narrow over-light. First floor front windows are of 6/2 sash while those above are of 6/6 sash all with wood lintels and sills as above the door, and there are louvered shutters. Rear area windows are also of 6/6 sash with wood lintels and sills. The attic is lighted by a small four pane window in each gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices and a double flue enclosed chimney rises on the left. The wing also has a moderate slope "A" frame roof and both are of metal. The house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
