DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story attached brick pair of houses, six bays wide and approximately three bays in depth with two story brick "U" shaped wings, 1-1/2 bays wide, with #218 being five bays long with a side balcony and brick dependency. #220 is four bays long with a rear balcony. All brickwork is of common bond. Round arched entrances occupy the right (S) bay of each house with double doors of glass over panels, white marble sills and dentiled transom bars. These are approached by 4 & 5 step newer porches. First floor front windows are wide and round arched, whereas those above are segmentally arched regular windows and all are of 1/1 sash. Rear area windows are of 6/6 sash with wood sills and lintels. The front section roof slopes to the rear and the wings have shed roofs. The Victorian "V" shaped cornice is rather modest with bands of mouldings and diagonal incisions and fluted brackets divide and end the bays. The building rests on a low foundation.
