**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a tall, three story brick townhouse detached and approximately three bays square with a full width, three bay deep wing. All brickwork is of common bond and painted. This house has been considerably altered with the front doorway bricked in and moved to the left west side. It is reached by a porch of eight sandstone steps with an iron railing. The paneled door has a five pane overlight and is framed by rather plain pilasters. Above this is a band of dentils and the whole is crowned by a flat wooden pediment trimmed by dentils. There are three front windows on each floor with 1/1 sash and brick segmental arches. The house has a high basement with three 2' front high windows on the front with segmental arches. Side windows are of 6/6 sash with louvered shutters. A three storied gallery covers the rear wall. In the center of the rear garden is a large gazebo of lattice work on a fieldstone foundation.

The front cornice is incised with vertical divisions in the center with bands of dentils above and below. Four evenly spaced fancy carved brackets terminated by acanthus leaf trim support this cornice and are tied together with a narrow "rope" moulding near the bases. Both roof sections are covered by a rather flat metal roof.
