DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Built by the Trail family in the late 18th century (per Mrs. Young, present owner). Their grandson built the mansion next door at 106 E. Church Street in the 19th century (1854). The house is now owned by Mrs. Mary W. (Howard) Young.

The detached three story brick house is three bays wide with a lower three bay long wing and one bay addition onto that. The wing is two bays wide and the addition is one bay wide, all extended along the west wall. The third floor was built about 75 years after the rest of the house. The roof of the front section is a very low pitched "A" frame of metal, and there are wide chimneys enclosed on either side. The chimneys have what appear to be wooden cornices around the top with dentils. Four small square chimneys are enclosed on the wing sidewalls. The wing and addition both have shed roofs of metal. All brickwork is of common bond. The doorway in the west front bay is enclosed by simple wooden pilasters with moulded capitals which support a flat wooden entablature. The recessed door is of four panels surrounded by sidelights with paneling beneath. Very narrow square pillars separate them from the door. Overall is a four pane transom with sidelights. The doorway is reached by sandstone steps with ornate cast iron railings. Windows on the front facade become shorter as they rise. Those on the third floor are 6/6 sash with those on the first and second floors being 1/1. All have flat brick arches, wooden sills and louvered shutters. Two horizontal 4/4 sash windows lie at basement level. There is only one window on the west wall of front section and is 6/6 sash with segmental brick arch. The wing has four irregularly spaced 6/6 windows with either flat brick arches or two newer ones with wood lintels and sills. Windows in the east wall of the wing are 6/6 sash with wood lintels and sills and have louvered shutters. A wooden gallery runs along the east wall of the wing and addition. A very plain boxed cornice projects from the front and rear rooflines. Some of the first floor wing shutters are paneled on the east side and a JIB window overlooks the brick patio. Interior of the house has interesting features and historic items. There is a nicely landscaped garden in the rear.
