## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, 3-1/2 story duplex detached on the west side. It is "U" shaped with the front section being four bays wide and deep, and narrow two bay square wings along east and west walls. The building has a mansard roof facade covered with slate shingles in a floral pattern. The metal roof then slopes to the rear with the two story wings having metal shed roofs. All brickwork is in common bond. Doorways are in the first and third bays from the west and are simple, round arched, double glass doors and overlights. Inside the vestibule are single doors with carvings in relief and glass transoms. Windows become smaller as they rise. The two first floor windows are very wide with big round arched overlights separated by horizontal mullions decorated with three dimensional diamonds. The second floor has two pair of three simple round arched 1/1 windows with center ones being taller. On the third floor are four smaller, simple round arched windows. All windows have round brick arches. The mansard roof has three projecting, evenly spaced, round arched fan windows. Rear windows all have 6/6 sashes. There is a large square enclosed gallery projecting from the west wing and a narrow balcony from the east wing. Several small chimneys rise from the\*  
 \*\*mansard section and consists of a wide band of delicately carved garlands. The frieze has three rectangular panels protruding from the ends and center. The ends contain carved garlands like those above and the center one has the carved date 1895. These projections taper at the bottom with mouldings and a row of dentils. Extending down from the bases of these are half round pillars with diagonal fluting and decorative endings. Extending from the bases of these are sections of three diamond shaped mouldings extending down to the bottom of the third floor level. #114 is entered by a cement porch and #116 by a granite stoop.
