DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very large three story corner home, four bays wide and extending back four bays and has a two story, two bay, one bay wide wing with an enclosed one bay wide second story porch leading off the east side. The wing extends off the west wall alley side. This house adjoins another house on the east. The metal roof slopes down for two bays then flattens out. The wing roof is also metal and flat. All brickwork is common bond painted on the front. The doorway is in the second bay from the west. It is enclosed by plain pilasters and topped by a flat entablature supported by long cyma curved brackets. The door has six graduating sized panels with an overlight. There is a low cement porch with iron railings. Front windows become shorter as they rise. All front and side windows are 2/2 sash, have wooden lintels and sills and louvered shutters. Windows in the rear porch are 6/6. The projecting wooden cornice has a top row of incised designs and tapers down to the frieze by mouldings. The front pavement is herringbone brick. There are remains of a landscaped garden at the rear. The house is set on a low foundation.

In 1978, the gardens have been restored.
