DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A very large three story house, four bays wide, two bays deep with a two story, four bay long wing which is two bays wide. This extends on the west side to the attached house. The front section roof is flat with a shed roof on the wing--both metal. Brickwork is common bond painted on the front. The wide doorway is framed by paneled pilasters, topped by a paneled architrave and a simple flat entablature supported by carved brackets. The outer two doors are glass paneled. The inner doorway has been divided into two entrances for the apartments upstairs. All front windows are 6/6 sash with projecting moulded cornices and wooden sills. The third floor windows are segmental arched with the same cornice design. All windows have louvered shutters. A two story gallery has a screened porch on the first floor. There are no side windows on the front section and other windows cannot be seen. A projecting cornice is supported by carved brackets with dentils in between. The wooden frieze is paneled and has a moulded lower edge. Chimneys are not visible. A herringbone brick pavement fronts the house. The house is set on a low foundation.
