DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A two story detached house with attic, this building is three bays wide and two bays deep with a four bay, two story long wing, two bays in width along the west side. The east end of the roof is moderate slope "A" frame (front section) while the west end slopes back from the peak to form the high side of the shed roof of the wing. All roofing is metal. Brickwork is painted common bond. There are wide brick chimneys at either end of the gable with a small one at the end of the wing. The doorway occupies the west bay and is composed of an attractive four panel door with three pane overlight and framed by simple Doric pilasters and a flat entablature. Brass door fittings and firemark above enhance the entrance. All windows, front and sides, are 6/6 sash, wood lintels and sills with louvered shutters. A gallery runs along the east side of the wing. The house sets on a low fieldstone foundation. It has a one step cement porch and a herringbone brick pavement.

Dormer windows were added in 1978.
