## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story pair of brick houses being six narrow bays wide and two in depth with "U" shaped wings two bays wide and three bays in depth with rear galleries. All brickwork is in common bond. Period doors with segmental arched transoms and scalloped transom bars occupy the end bays and are approached by brick steps and iron railings. All front windows are of 1/1 sash with those on the first floor being wider and those on the second story are quite narrow. All have segmental brick arches of shaped voussoirs with infills adorned by carved roundels and panels and are headed by brick header drip moulds as above the doors. The cellars are mostly above ground with front entrances and windows headed by flat brick voussoir arches. There are no side windows but those on the wing area have 6/6 sash with wood lintels and sills and louvered shutters. The front section roof slopes to the rear, the wings have shed roofs and all are of metal. The front roof cornice is Victorian "V" shaped and decorated by bands of incised crosses and a band of small quarter-round dentils ends the brick frieze.

The building rests on a low fieldstone foundation and bricked-up cellar walls, 1/2 above ground level.
