DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A detached duplex pair of very wide three bay (each) houses which are 2-1/2 stories high with attic, the front sections extend back three bays and the building is "T" shaped with a central, four bay wide wing extending back four bays with a one bay extension two bays wide. A balcony runs along either side of the wing. The front section has a metal, steeply pitched, "A" roof with a wide enclosed chimney at each gable and the central wing has a metal roof with a very gentle slope to the peak and with two small chimneys at the gable ends. Brickwork is common bond and has been recently restored to its natural salmon color. The doors (front) are in the central two bays and have three graduated panels with an overlight. Doorway framing is paneled. Porches are one step high and enclosed by iron railings. A herringbone brick pavement fronts the house. All windows are 6/6 with flat brick arches. Rear windows have louvered shutters. The front facade also has louvered shutters. The cornice is a simple three string brick, common for the Federal period. Both rear yards have attractive lawns and plantings. The building sets on a very low fieldstone foundation. This was built in 1843 per the Myers (present owners).

#210 has a JIB window-door leading off the living room to the garden.
