DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A large 2-1/2 story home which is three bays wide, two bays deep and detached on the west side, this building has a five bay long, two bay wide wing extending back along the east wall. The front section has a steep metal "A" frame roof and the wing has a metal shed roof sloping to the west. There are double chimneys enclosed in the end walls of the front section which have double Gothic arched caps. All brickwork is of common bond and the house is faced with a salmon colored brick. There is an attractive four paneled door in the east bay with brass hardware, an overlight, and a two step porch with an iron railing and a gas lamp. A herringbone brick pavement enhances the front. Front windows are 1/1 sash with wood sills and louvered shutters. The front facade has gauged flat brick arches over the windows, the door, and the front basement windows. Most of the wing windows are 6/6 sash with wood lintels and sills. Those on the first floor have raised square ends with roundels. A JIB window is on the exposed west bay of the rear of the front section. The wing doors are paneled. A balcony runs along the west side of the wing. The front has a three string brick cornice with the middle row laid at an angle (diagonal) to give a sawtooth effect. The fieldstone foundation is very low. A very long grass and flower garden with patio extends from the rear. The interior of the house has been tastefully arranged for modern living.
