DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This detached house is 2-1/2 stories high, three bays wide and two bays deep. A four bay wing runs along the west side and is two bays wide. A one bay square wing adjoins the rear of that. The front section has a moderate slope "A" frame roof of metal with a shed roof extending from the west gable to cover the wing--also metal. An enclosed chimney is also in the west gable end. Brickwork is common bond. The front door is glass paneled in Victorian design and has an overlight. A slatted steep canopy has been added in recent years. The doorway occupies the east bay. All front windows are 1/1. The first floor front windows have a projecting moulded cornice arched in the center with roundels below. Second floor front windows are shorter and have flat lintels with moulding at the top and louvered shutters. All windows have wooden sills. First floor windows have cast iron window box grilles on the front. Side and rear windows have wood lintels and sills, 6/6 sash and louvered shutters. A balcony and porch below project from the east wall of the wing and terminates at the one bay wing extension wall at the rear. This section contains two windows and two doors on each floor. A two string brick cornice follows the front roofline. Iron railings line the one step front porch. The house has a very low foundation. A herringbone pattern brick walk fronts the house.
