DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story, three bay wide and two bay deep brick house. It has a 2-1/2 story wing along the west side which is five short bays deep and two bays wide. At the end of that is a one bay square wing along the east wall. This building is detached on the west side only. Both sections have metal "A" frame roofs, also the end addition. An enclosed chimney protrudes from the west wall of the front section and the rear wall of the wing. Brickwork is of common bond and painted. The front door in the east bay is glass paneled with Victorian divisions and an
 →  with moulding across
 the top and wood sills. The wing has four windows across the second floor
 and three on the first floor with two doors--on the west side. Windows are 1/1 and
 with wood lintels and sills and louvered shutters. A gallery runs across the west wing
 wall with a porch under it. Two small windows are on either side of the chimney in
 the attic. A three string brick cornice runs along the front and back roofline of the
 front section. The house is built on a very low foundation and has a herringbone brick
 pavement.
