

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story three bay wide and three bay long house with a five bay long, two bay wide wing with a small extension on the first floor. This building is detached and all brickwork is common bond. The wing has been raised on the west side to a full two stories, according to brickwork. The front section has a metal steep slope "A" frame roof with a chimney. The wing now has a shed roof of metal sloping from the west wall and with a chimney enclosed. The doorway occupies the west bay and four paneled with a decorative overlight.  This is reached by a one step porch with iron railings. All front windows are 1/1 with wood sills and louvered shutters. Lintels for windows and the doorway are wood with moulded trim along top edge. Only two small windows are on the west wall, but the east wall of the wing has four windows and a central door on each floor. Windows are 6/6 sash with wood lintels and sills and louvered shutters. A gallery runs along the east wall of the wing with a porch on the first floor. The front cornice is a very simple boxed type and the neighbor states that Victorian trimmings have been removed. The house has a very low foundation in front and high in the rear with the grade.
