DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story, three bay wide and two bay deep house with a two bay square wing along the detached west wall. A small extension runs off the first floor. This building is part of a "U" shaped double structure with separate center walls. The east side of the wing is covered with shingles with no lintels or sills visible for windows which are 6/6. The front section is moderate slope "A" frame and rear wing is shed type sloping to its adjoining house on the east. A chimney is in the west gable, enclosed. All roofing is of metal. The front door occupies the center bay with a board and batten door in the east bay opening through an alley covered by the second floor to the yard. The front door is glass over panels. The front windows are all 6/6 with wood lintels and sills and louvered shutters. Doorways also have wood lintels. Brickwork is common bond and painted. The cornice is three string brick. The low fieldstone foundation is faced with brick on the side and cement on the front. The front porch is one step high with iron railings and there is a herringbone brick pavement. A modern metal slat canopy hangs over the porch.
