DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is now a tall, two story brick detached pair of houses, six bays wide and approximately five bays in depth with a two story brick "T" shaped wing approximately four bays square with rear balconies. All brickwork is in common bond and sidewall evidence shows this to probably have been a 1-1/2 house because of its old soft brick now faced on the front with a later brick. Round arched entranceways of paneled double doors with white marble sills and transom bars decorated in a garland motif occupy the outer bays. Wide round arched windows lie in the inner bays and three smaller round arched windows front the second story of each house and all are of 1/1 sash with three row header brick arches. Rear area windows have 6/6 or 1/1 sash with segmental two row header brick arches. The front section roof slopes to the rear and the wing has a low "A" frame roof. The Victorian "V" shaped cornice is decorated with bands of incised crosses, beading, and mouldings on a wooden frieze with three long moulded brackets at the center and ends. This building sets on a rather high fieldstone foundation and is fronted by a herringbone patterned front pavement.
