DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story, two bay square house with a two bay square wing and a one bay long, two bay wide frame addition to the rear also of two stories. This house was built adjacent to those on either side but wings have a detached west side due to an alleyway and by extending bay and house on the west side. The front section roof is moderate slope "A" frame of metal with the wings having metal shed roofs sloping toward its neighbor on the west. A chimney is enclosed in the east gable. Brickwork is common bond and painted. The west bay front door is a glass panel and wood lintel above. Front windows are 1/1 with wood lintels and sills. Side and rear windows are 6/6 with wood lintels and sills. A gallery runs across the back. A three string brick cornice runs along the front roofline. The door is approached by a one step high porch with iron railings. The low foundation is faced with brick. A herringbone brick pavement fronts the house.
