DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story separate row house two bays long and one bay wide. It has a one bay wide, two bay long wing also two stories. The front section has a moderate slope metal "A" frame roof and the wing has a metal shed roof sloping to the east. There seems to be a double chimney stack serving this house and the house next door on the east extending from the "A" roof. All brickwork is common bond. A four paneled door with overlight occupies the west end of the bay and has a wood lintel. There are two 6/6 sash windows very close together on the second floor front facade and one 6/6 sash window beside the door on the first floor. Front windows have wood lintels and sills and louvered shutters. Rear windows are also 6/6 sash with wood lintels and sills. A balcony runs across the end of the wing. The cornice is a very simple box shape. The fieldstone foundation is very low. The pavement is of a herringbone brick pattern. All building brickwork is painted.
