DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, three story building being three bays wide on Market Street and five bays in depth on W. Church Street. This building has a flat roof-material not visible. The street sides are faced with a white brick while the rear sides are of common bond. The first floor is made up entirely of plate glass windows on the street sides with a door at the corner. The second and third story windows above are double sections with single windows at the ends of the building. They have 1/1 sash with two row flat brick arches and cement sills. Both street facades are arcaded with shallow piers between the window sections on the second and third floors and are topped by cement segmental arches containing large keystones of the same material. "*Rosenour Building*" is set in long panels between the second and third floor windows. A doorway to the apartments occupies the west bay and contains double glass doors with an overlight and topped by a cement pediment supported by cyma curved fluted brackets. A wide protruding cornice with closely spaced cyma curved brackets and a moulded wooden frieze beneath extends around the street sides. This is surmounted by an approximately four foot high parapet all around the building and made of the same white brick facing.
