DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick pair of houses detached on the right (N) side and is approximately six bays wide and two bays in depth. They share a two story brick "T" shaped wing approximately four bays square with side balconies and newer brick and frame rear extensions. All brickwork is in common bond. This was formerly a 2-1/2 story house and the old soft salmon colored brickwork of the sidewalls has been faced on the front wall. Front entranceways occupy the outer bays with glass paned doors and segmental arched transoms and are framed by moulded wood architrave, which also surround first floor windows of 1/1/1 sash. Second story front windows are also segmentally arched with 2/2 sash and ornate cornices with bands of curved dentils and small fluted end brackets. The infills are ornamented with wavy incised lines. The narrow end bays contain enclosed passageways to the rear yards and are fronted by gates with ballustrades of turned pillars. Rear windows are of 6/6 sash. The front section roof slopes to the rear and the wing has a low "A" frame roof. The front Victorian cornice is decorated by a wide band of incised designs and scallops with a moulded band of pointed dentils ending the frieze. The bays are accented by richly moulded and scrolled brackets ended in a foliated design. This building rests on a low fieldstone foundation. The front facade has been built up to the former ridge level.
