## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story, six bay wide, five bay long duplex apartment and office structure detached on the west side. It has a flat metal roof sloping to the rear. The "T" shaped wing is approximately five bays square with side galleries and a flat metal roof. Chimneys are enclosed in the sides of the front section which is of common bond. The more recently added wing is of miscellaneous materials. Round arched recessed doorways with overlights occupy the inner bays on all three floors. On either side are round arched 1/1 sash windows with arches of gauged brick. Three string brick belt courses tie these together across the facade on all three stories. A wide front porch covered by the gallery section of the upper floors covers the entire front. They are supported by Doric pillars and decorated with rows of dentils. Decorating the front roofline is a very elaborate projecting Victorian cornice of many mouldings and small brackets. Side windows are 1/1 sash with wood lintels and sills.
