DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story duplex building. It is five bays wide and two bays in depth. The "T" shaped rear wing is five bays long and approximately three in width and has long porch balconies on either side. The roof of the main block is a shingled "A" frame of a moderate slope. The wing has a slight slope metal "A" frame roof. There are three enclosed chimneys on the front section and two on the wing. All brickwork is of unpainted common bond.

Doorways occupy the second bays from each end and are simple paneled doors with #135 having glass panels in the top section and both with round arched overlights. #133 is just two bays wide so the central windows are part of #135. This building has a very high basement on the front elevation so doorways are reached by seven or eight step concrete porches. The basement windows are about two feet above the field-stone foundation. The three first floor front windows are double 1/1 sash with fluted mullions. Roundels crown the architrave. All first floor front openings have three course segmental arches of header brick. The second floor front windows and those on the sides and rear are all of 2/2 sash with louvered shutters and two course header segmental arches. An exception to this is the windows of the second floor which have wood lintels. There is a three string brick cornice along the front and back roofline of the main block. #135 has a long cement porch with iron railings under the second floor porch balcony.
