DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is historically and architecturally important because of a stone wall section, the remains of an older building on this site.* This rises up to the second floor level on the west and south sides. Otherwise, the house appears to be turn-of-the-century architecture. It is of two stories, four bays wide and one bay deep and is a corner house. In an "L" shape is a five bay long, two bay wide wing covered with modern siding. A flat metal roof covers the front section with the wing having a metal shed roof. There are chimneys on either side of the front section and one on the rear of the wing. The front section is of unpainted common bond. The doorway occupies the east bay and is a simple horizontally paneled door with a rectangular overlight. All windows are of 1/1 sash with the front having two course header segmental arches with roundels and paneling in the infills. This same type arch is also over the front doorway. In the stone wall section on the rear of the house is a 1/1 sash window with an old wooden lintel and sill. This building is near a creek and has a high fieldstone foundation covered by concrete. A Victorian cornice with one row of dentils and another of diamond designs fronts the roofline. It also contains three long brackets and a band incised with blocks tying in the bases of the brackets.

*More recent research reveals this to be a wall of a tannery constructed along the creek by Colonel Shelman, the surveyor of Frederick, for David Dulaney in 1745.
