DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story building, part of a row, five bays wide and approximately three bays in depth. A "T" shaped wing, three bays wide and five bays in depth extends to the rear and is two stories in height. Both sections have low sloped "A" frame roofs with the front being of a composition material and the rear of metal. No chimneys are visible. All brickwork is of common bond. The front facade has been recently reconstructed into an attractive colonial design. Three doorways occupy the end and center bays. They have glass over wood panels with rectangular overlights. Between the doorways are rectangular window areas of a colonial design with twenty to thirty panes with wood paneling beneath. The first floor doors and window areas are tied together by a projecting box cornice and a wooden frieze with the name "Trout Building" in the center. On the second floor front are five 6/6 sash windows with metal lintels, wood sills, and louvered shutters. A three story brick cornice fronts the roofline. The wing windows are of large 6/6 sash and have two row header segmental arches. The building has a low fieldstone foundation. This is a good example of converting a rather plain building of no particular style into an office building blending in with area architecture.
