DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small, low Federal style detached brick, 1-1/2 story office building, five bays wide and two bays in depth with a one bay square "L" shaped brick wing. The front facade is laid in Flemish bond. Front entranceways occupy the second bay from each end with newer glass over panels doors and old four pane overlights. #104 has a well-worn fieldstone step. All windows are of 9/9 sash except that of the left (N) front bay which has 12/12 sash and all have flat brick arches, as over the doors, and louvered shutters. The attic is lighted by two small windows in each gable with either louvered or board and batten shutters. The front section has a steep "A" frame roof with newer fish-scale-shaped concrete shingles and small enclosed chimneys rise from each gable. The wing has a shed roof and both are ended by simple boxed cornices. This has a street level foundation and is fronted by a herringbone patterned brick pavement.
