**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

A set of three attached, late Federal townhouses in fair condition, they are 2-1/2 stories with "A" roof and common bond brick. Each one is three bays wide. All the windows are new sashes but have wooden sills and lintels. Simple doors with overlights. A wooden roof cornice connects all three structures. Each one has two 6/6 pedimented dormers on its front roof. The house to the west has had a Victorian bay window added over its door.
