DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick house detached on the right side and two bays wide by three bays in depth. This was probably built as a wing law office to #19. All brickwork is of common bond and recently restored. The front entranceway has a four panel door, a paneled enframing, overlight, and is entered by a two step porch of marble. All front windows are Victorian, multi-paned with flat brick arches of shaped voussoirs. Rear windows are of 6/6 sash with wood lintels and sills or flat brick arches and all have louvered shutters. The rear door has glass over panels with a three pane overlight. The roof slopes to the rear with a right sidewall parapet. The front projecting roof cornice is supported by closely spaced cyma-curved moulded brackets on a raised brick frieze. The building rests on a low fieldstone foundation. The front pavement is laid in a brick herringbone pattern. There is a brick patio to the rear and an old brick carriage house.
