DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#36 is of 2-1/2 brick stories, is detached, three bays wide, two bays in depth, and has an "L" shaped, two story brick wing, two bays wide and approximately five bays long with a side gallery and a one bay square extension. The entrance consists of a four panel door surrounded by Doric pilasters and occupies the west bay. It is headed by a single pane transom. This is approached by a brick porch with an iron railing. All windows are of 6/6 sash with moulded top lintels on the front and regular wood lintels and sills in the rear. Windows are protected by louvered shutters. An iron "busy body" projects from an upstairs window. On the rear of the front section is an old JIB window-door. The front section is capped by a moderate slope "A" frame with the wing having a shed roof and both are of metal. The attic is lighted from the left by two 4/2 sash. Chimneys rise from each gable. To the rear is a small garden with lawn, evergreens, and statuary.
