DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#101 is a three story corner, detached brick house, three bays wide and five bays in depth with a two story, brick "L" shaped wing, two bays wide and five bays long with a side balcony and a one story, one bay square dependency.

This house has a very tall entranceway like its neighbor at #103. It has double doors of five panels, each with carved ovals of Federal style; a paneled enframing, four pane overlight, and the whole is framed by a classic entrance of Doric pilasters supporting a flat entablature with dentil trim. Copper coach lights add eye appeal. This is approached by red sandstone steps with wrought iron railings. A wide vestibule has a Federal style three part doorway with round arched panels, sidelights separated by square attached pillars with moulded capitals supporting a heavy moulded transom bar and a four pane overlight.

Windows are of 6/6 panes with wooden sills. These are headed by flat brick voussoirs on the front and wood lintels on the rear. These have louvered shutters. On the rear of the front section is a 6/6 sash JIB window-door with long shutters of panels over louvers. There are four panel doors with paneled enframements and three pane overlights.

The roof is fronted by a bracketed cornice, slopes to the rear, and the wing has a steep shed roof, also of metal. Triple and double flue chimneys rise from the roofline. The building rests on a fieldstone foundation. There are rear gardens.
