**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#104 is a three story brick home detached on the left (E) side, and is three bays square. This is joined by a two story brick "L" shaped wing, five bays in depth and two bays wide with a long side balcony, a one bay long extension, and a one bay square, one story dependency, also of brick. This wing appears to be older than the front section, but the top of the right wall shows no breaks. Star design brace terminals appear on the exposed left wall.

The entrance occupies the right (W) bay with a round arched transom and dentiled transom bar. Front windows are of 2/2 sash with segmental brick arches and wood sills. Those on the rear area are of 6/6 sash with wood lintels and sills. On the rear of the front section is a 2/2 Federal style JIB window-door with long shutters of louvers over panels. Rear area doors have glass over panels.

The front section roof slopes to the rear and the wing has a shed roof, both being of metal. The roof cornice is supported by moulded and fluted brackets dividing the bays. In between are richly moulded modillions and a band of moulded dentils. The frieze contains wooden panels with incised foliated designs.

This house rests on a fieldstone foundation.
