DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#105 is a two story brick home, detached, and three bays square. This is joined by a lower, two story brick "L" shaped wing, seven bays long and two bays wide with a long side gallery, part of which is enclosed. To the rear is an extension of three bays being one bay wide and with a rear gallery. Brickwork is in common bond.

The entrance occupies the left (W) bay with a round arched, six paneled door headed by a fanlight. This is approached by a brick porch with iron railings.

Front windows are of 2/2 sash with segmental arches of shaped voussoirs, wooden sills, and louvered shutters. On the rear of the front section are JIB window-doors of 2/2 sash and long louvered shutters on both floors. Wing windows are of 2/2 sash and the extension has small 6/6 sash windows, all with louvered shutters, wood lintels and sills. There are four paneled doors with rectangular transoms.

The roofs are flat metal. Enclosed brick chimneys rise from the front section sidewalls. A boxed cornice decorated with dentils fronts the house and extends around the front corners.

This building rests on a fieldstone foundation. To the rear is a small landscaped garden with a large Magnolia tree, a Cherry tree, boxwoods, evergreens, shrubs, ground covers and a lawn area. The wing is serviced by a herringbone brick patterned patio.
