DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of three story brick homes approximately four bays square detached on the right (W) side. To the rear are two story brick "U" shaped wings, 1-1/2 bays wide and three bays in depth with rear balconies. All brickwork is laid in common bond.

The entrances occupy the outer bays with doors of three or six panels and round arched transoms. These are approached by brick or wooden porches with railings and white marble sills. #106 is especially attractive with turned balusters and newel posts.

Front section windows are of 1/1 sash with wooden sills, round arched on the first story and segmental arched above with two row brick headers. Wing windows are of either 2/2 or 1/1 sash with two row header brick segmental arches.

The front section roof slopes to the rear and the wings have shed roofs, both of metal. The roof cornice is of Victorian design with a band of incised "V's" diamond shaped floral motifs, carved dentils, and a band of cross-shaped quatre-foils. The bays are divided by fluted carved brackets.

Fronting the houses is a herringbone patterned brick pavement. To the rear of #106 is a small landscaped patio garden with brick paving, wisteria vines, evergreens, statuary and seasonal flowers.
