DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of tall, three story brick houses, six bays wide, two bays in depth and attached on each side. To the rear are "U" shaped wings with #108 having three stories and #110 being of two stories and both are four bays in depth. Both have rear galleries. All brickwork is of common bond and #110 has been recently restored.

Entrances occupy the right (W) bay of each house with paneled doors and flat entablatures.

The front windows contain 2/2 sash, segmental arches and wooden sills. Rear windows are either of 2/2 or 6/6 sash with wood lintels and sills.

#108 is entered by a decorative cast iron porch. Front section roofs slope to the rear and the wings have shed roofs.

Front facades are crowned by box cornices trimmed with dentils and decorative brackets which are joined by a band of moulding. These are mounted on a projecting brick frieze.
