DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses detached on the right (N) side and is five bays wide and three bays in depth and they share a full width two story brick wing, two bays deep with rear galleries on #305. All brickwork is in common bond. Front entrances occupy the center bay and the second bay from the right. #305 retains an old four panel door with a three pane overhead and #307 now has a newer door with a larger oval pane decorated at the corners by foliated carvings. #305 retains mostly 6/6 sash on the front and rear, all with wood lintels and sills. The attic of #305 is lighted by a small four pane window in the right gable. The front section has a moderate slope "A" frame roof resting on two string brick cornices and with double flue enclosed chimneys rising at each gable. The wing has a moderate slope lower "A" frame roof with a large chimney on the end. The houses rest on a low fieldstone foundation.
