DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large rectangular school building, three bays wide and nine bays in depth with a four bay, full-width extension. All brickwork is in unpainted common bond and the front has been faced with a small pressed ribbed brick. In the center is a large entranceway with double doors headed by a Victorian-style transom and an impressive framing of attached Doric pillars supporting a pediment with a broad frieze. This is surmounted by a gold cross. On either side are recessed 8/8 sash windows with four pane transoms. The bays on the upper section of the front facade are divided and ended by brick piers with Ionic capitals and bores (similar to St. John's Church next door), but these support a metal cornice and a brick frieze. In between are three section windows with 12/12 sash and narrow 6/6 sash sidelights divided by paneled mullions. A moulded metal cornice "supports" the bases of the piers at the second floor level and continues around the first side bays as does the overhanging metal roof cornice with dentil trim. Rear area windows are in pairs of 2/2 sash with soldier course flat brick arches. The roof sections are rather flat. The building "re^{*}sts" on a high foundation.
