DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses, detached on the left (S) side and now five bays wide and approximately three bays in depth with a full width wing section. According to brickwork evidence, the right bay of #309 was added. The wing of this house is two bays in depth with rear galleries and #311 has a three bay deep wing with enclosed side galleries and both are of brick, all of which is in common bond. Front entranceways occupy the second and fifth bays from the left. #309 now has a wider entrance with double doors headed by a four pane overlight and framed by Doric pilasters and a flat entablature. This leads to a wide vestibule with a three part inner entrance of double round arched doors and glass pane sidelights and overlights. #311 also has a newer door with a narrow overlight. #309 now has 2/2 sash windows on the front second story, but all others, including #311, have 1/1 sash, except for 6/6 sash on the wing of #311. The attic of this house is lighted by a small, four pane gable window. The front section has a moderate slope "A" frame roof resting on two string brick cornices. Wide enclosed chimneys rise from the left gable and the original end of #309 on the right. The building sets on a low fieldstone foundation at the front level.
