## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick pair of houses, attached, four bays wide and six bays in depth with "U" shaped wings, two bays square and rear balconies. The wings of #211 are of three stories and #213 are of two stories in height. All brickwork is unpainted common bond. Round arched entranceways occupy the outer bays with large paned doors ended by small moulded lugsills. These are topped by round arched transoms. They are approached by four step brick porches with wrought iron railings. In between are two large, round arched 1/1 sash windows with three row header arches as over the doorways. Bay windows occupy the second story end bays and all other windows on the front and rear are of 1/1 sash with segmental, two row header brick arches. The roof of the front section slopes to the rear and the wings have metal shed roofs. The front cornice line is of Victorian design with bands of incised motifs, square floral bosses, pointed square pendants and quatre-foils. The bays are emphasized by long fluted brackets. This building has a high foundation.
