DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the right side. It is approximately three bays square with 1/2 of a 2-1/2 story brick "T" shaped wing, five bays long and 1-1/2 bays wide with a one story, three bay long dependency extension. All brickwork is of common bond. The front entranceway of Tehan style\* occupies the left bay with a marble sill. This is approached by a low porch with a very attractive cast iron railing. First and second story windows are of 6/6 sash with flat brick shaped voussoir arches and louvered shutters with windows on the second story being smaller. Above those windows are two brick belt courses and three low 4+4 casement "bee brow" or "lie on your stomach" windows. The attic is lighted by two 6/6 sash windows from the right gable. All wing windows are also 6/6 sash with wood lintels and sills and louvered shutters. There are newer rear doors except for old board and batten doors on the dependency extension. The wing is lighted by 6/6 windows from the end. The front section has a moderate slope "A" frame roof with a double flue chimney rising from each gable. The wing has a steep slope "A" frame roof and all are of metal. The front roofline has a narrow boxed cornice. The house rests on a low fieldstone foundation. There is a brick dooryard patio and lawn area to the rear.

## STATEMENT OF SIGNIFICANCE

This house is part of a row of larger houses of Victorian times constructed by local builder, John Tehan, who built the nearby St. John's Catholic Church. They all display his trademark decor such as six panel doors, paneled enframements, pilasters with moulded "returns" at the top and bottom and headed by moulded flat entablatures and with boxed roof cornices with \*  scrolled brackets on the others.

A plaque on the front wall denotes this house as being over one hundred years old with no significant front facade attractions.
