## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick attached house approximately three bays square with an "L" shaped, two story, two bay square brick wing, a two story frame extension one bay wide and five bays long, and a one story, one bay square masonry extension. All brickwork is in common bond. The front entrance occupies the left bay with a four panel door of Victorian decor with a segmental arched transom. All front windows are of narrow 1/1 sash with segmental brick arches of two row headers with the top row forming a hood mould and long bricks forming "keystones." Second story windows are shorter and the doorway has the same style arch. Rear windows are 2/2 sash with wood lintels and sills. The front section roof slopes to the rear and the wing has a shed roof with both being of metal. The front roofline has an ornate Victorian cornice richly incised with various motifs and moulded brackets divide the bays. In between are wooden panels incised with foliage. The frieze is ended by a band of quarter-round dentils. The building sets on a low fieldstone foundation.
