## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick attached house three bays wide and two bays in depth with a three story frame "L" shaped wing, two bays wide and four bays long with side galleries and a one story brick and frame extension. All brickwork is of common bond. The front entranceway occupies the left bay with a four panel door, a paneled enframing and three pane overlight. All front windows are of 1/1 sash with wood sills and lintels as over the doorway. Rear area windows are of 6/6 sash and there are four panel doors. The roof of the front section slopes to the rear and the wing has a shed roof, both of metal. The front roofline has a moulded cornice supported by closely spaced carved brackets with turned pendants on a raised brick frieze. The house sets on a high foundation.
