#242 is a two story, flat roofed, brick pattern shingled house which faces North on E. Second Street. It is a residential building and is detached.

The principal facade is three bays wide and four bays in depth and the entrance door is located in the N/W corner. It is a six paneled door with simple wood frame. All windows are 6/6 sash, double hung with wooden sills, and they are shuttered. Very plain eaves overhang. There is an exposed cement foundation and also a cellar entrance and small exposed cellar windows. Five steps lead to a brick stoop with an iron rail. The roof slopes to the rear.

This house has been very nicely renovated on the interior.
