DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#1 is an attached 2-1/2 story brick former house, three bays wide and three bays deep including a one bay deep, two story section. This is joined by a three story, full-width, five bay deep extension wing. Front brickwork is laid in Flemish bond. The first floor has been altered by a new "colonial" crossbuck door and a classic entranceway of fluted pilasters headed by a simple flat entablature in the left bay (West bay). The remaining two bays are now fronted by a wide, rectangular small paned "window" section fronting the brick wall. Enclosing the doorway is a small colonial lamp lighting colonial office directory plaque. The front, second story windows are deeply recessed and have 6/6 sash with new metal lintels and flat soldier course brick arches. These are protected by louvered shutters. The entire first floor is covered by an overhanging shingled pent roof. Rear area windows have two row header segmental arches, but newer sash. The front section has a moderate slope "A" frame roof with no visible chimneys, is of metal, and is fronted by a plain boxed cornice. The building sets on a low foundation, probably of fieldstone.
