DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#3 and 5 is a 2-1/2 story brick house now detached on the left (W) side. It has been extensively altered for the present business operation, and the front facade has been sheathed with a formstone type material. The building is approximately three bays square.

The shop is now entered at the center and an entrance in the east bay leads to the upstairs apartment. Large shop windows now light the first floor with three unevenly spaced regular windows with metal lintels on the second floor. Two dormers light the attic from the front with 9/6 panes headed by stepped pediments (probably original). It is said that a single dormer extends from the rear of the roof with 6/6 sash and a peaked roof.

A brick, two story "L" shaped wing, 1-1/2 bays wide and three bays in depth with a newer, one bay extension, extends from the rear. This contains 6/1 sash original windows with wood lintels and sills and also newer windows.

A wide enclosed chimney rises at the west gable with a smaller one on the east end.

The building sets on a low foundation and the front pavement has been recently paved in a herringbone pattern of brick. A new patio (brick) now enhances the rear area with raised brick planters, small trees, evergreens, statuary and ground covers.
