DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#19 is a 2-1/2 story brick corner house, three bays square with a 2-1/2 story, brick "L" shaped wing, three bays in depth and 1-1/2 bays wide with a side balcony and one bay extension. The front facade is laid in Flemish bond and all other is in common bond. A rather simple, Federal entranceway occupies the right (E) bay with a large, four panel door with a paneled enframing and rectangular transom and wood lintel. This is approached by a brownstone sill and two step porch. Front windows are of 6/6 sash with wood lintels and marble sills and louvered shutters. Side and rear area windows are of 6/6 or 12/12 panes, all with wood lintels and sills and louvered shutters, except the paneled shutters on the left street side of the first floor. Wing doors have panels and three pane overlights. The front section has a steep, "A" frame roof with a three string cornice on the front. Sidewalls rise to form roof curtains with buttresses and pairs of double flue enclosed chimneys joined by wide curtains rise from each side gable. The wing roof has a steep shed construction and connects to the main roofline at the peak. Both are covered by metal. This house rests on a low fieldstone foundation. The front pavement is laid in herringbone patterned brickwork with a flat, double iron pair of cellar doors with the manufacturer's name, "*Henry Pampel--Frederick, Md.*" and floral decor. To the rear is a large, neglected garden leading to an old, 2-1/2 story stable and carriage house with vertical vents in the gables and an hourglass vent on the front wall with board and batten window shutters.
